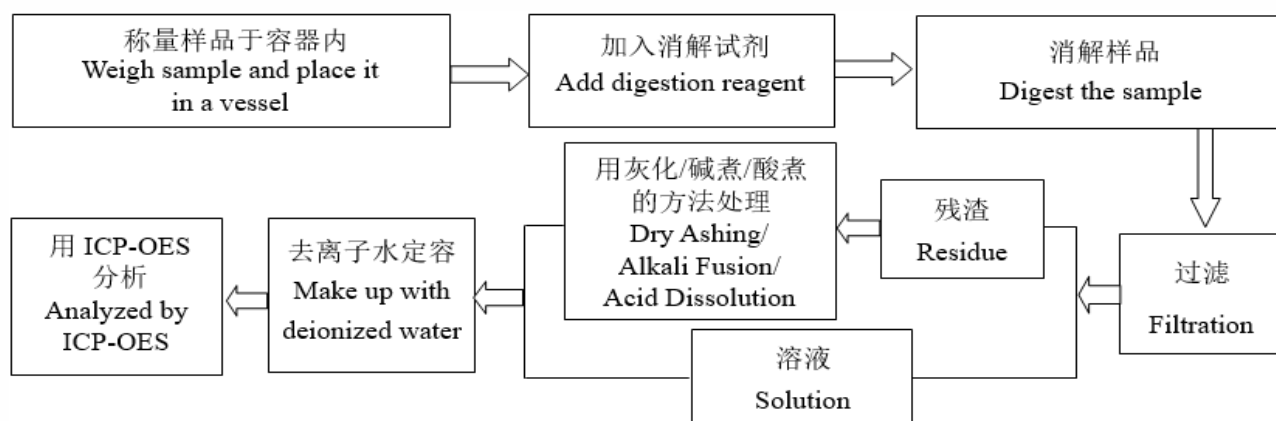

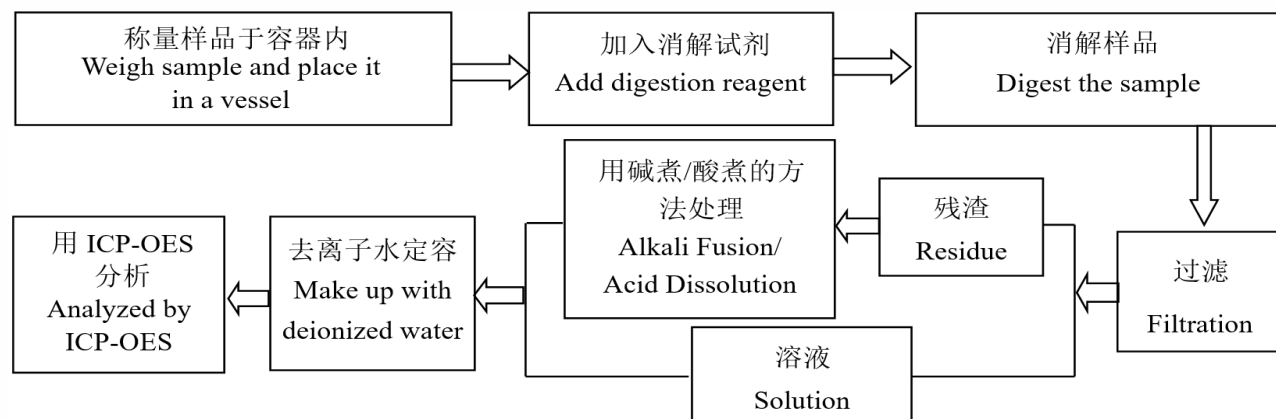

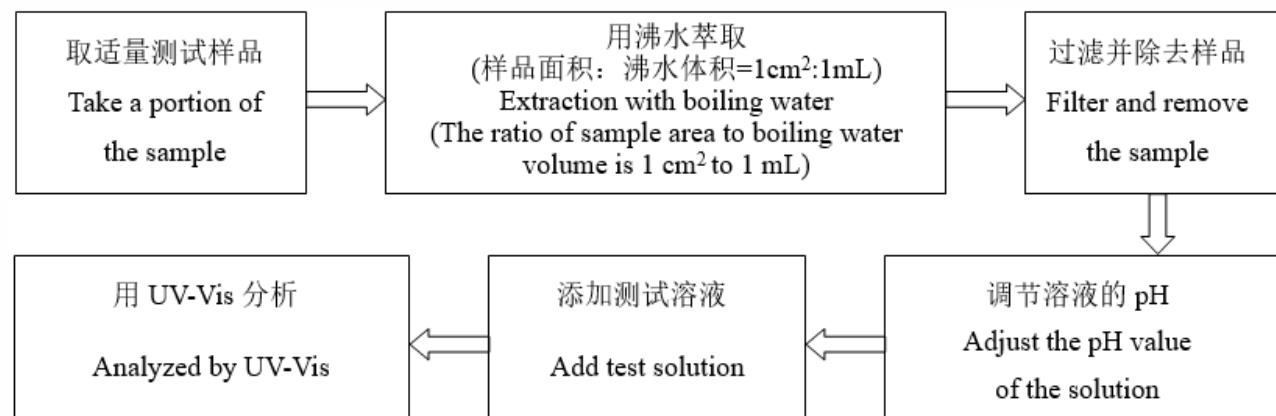
1. 铅 Lead (Pb), 镉 Cadmium (Cd)

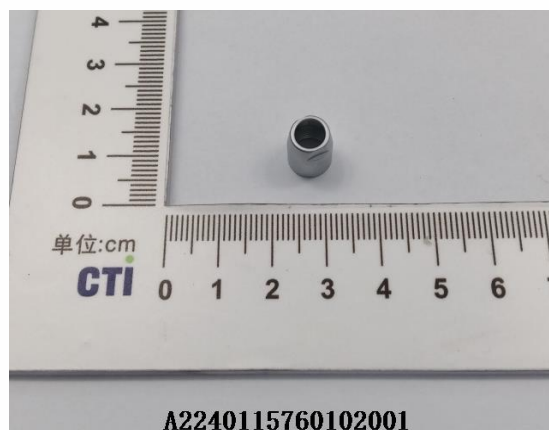

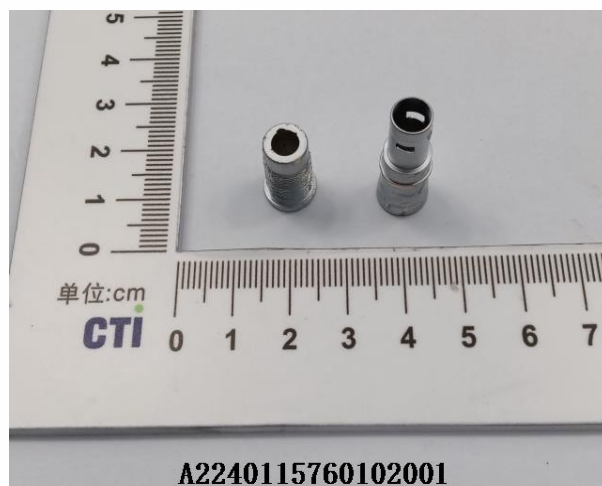
